THE INTERNATIONAL CRIMINAL TRIBUNAL FOR RWANDA (the "Tribunal"),

SITTING as Judge Jai Ram Reddy, as designated by the President of the Tribunal pursuant to Rule 28 of the Tribunal's Rules of Procedure and Evidence;

BEING SEIZED of the "Prosecutor's *Very Urgent* and *Ex Parte* Motion to Rescind the Non-Disclosure Order of 22 July 2005 Relating to the Indictment Against the Accused, and the Issuance of a Warrant of Arrest Against the Accused", filed on 12 June 2007, and the Corrigendum thereto, filed on 13 June 2007;

RECALLING the Indictment against Laurent Bucyibaruta, filed on 16 June 2005 and confirmed on 17 June 2005;

HAVING CONSIDERED Rules 52 and 53 of the Tribunal's Rules of Procedure and Evidence;


HEREBY DECIDES the motion.

1. In its initial request for confirmation, the Prosecution requested that the Indictment against Laurent Bucyibaruta be placed under seal. In accordance with Rule 53 and in the interests of justice, the confirming judge granted this request and ordered the non-disclosure of the Indictment, all related orders, and all supporting materials to the Indictment as part of its confirmation decision of 17 June 2005.
2. The Prosecution has now made an application to have the Indictment unsealed on the grounds that the interests of justice are not served by keeping the information from the public.
3. In the Tribunal's view, non-disclosure measures are no longer necessary with regard to the Indictment. The Tribunal maintains, however, the protective measures ordered in connection with the supporting materials to the Indictment.

FOR THE ABOVE REASONS, THE TRIBUNAL

ORDERS the unsealing of the Indictment against Laurent Bucyibaruta.
